The International Association of Hydrogeologists (IAH) invites companies who work in the field of groundwater and the environment to become corporate members of the Association. Corporate membership of IAH will provide promotional opportunities for your company, give groundwater professionals on your staff the benefits of personal membership of the Association and improve the resources of IAH to carry out its mission. IAH is the premier, truly international organisation for scientists and engineers working in the fields of groundwater resource planning, development, management and protection. Founded in 1956, we have grown with the increasing environmental and social importance of groundwater to an organisation of over 4000 members in nearly 140 countries.

**The mission of the Association is:**

- to advance public education and promote and disseminate research in hydrogeology;
- to promote understanding of issues relating to groundwater and its use and protection and to enhance the role of groundwater professionals throughout the world.

The membership of IAH embraces professionals from many related disciplines who have the common goal of the better protection and use of groundwater for the benefit of mankind. IAH works with agencies in the UN system, especially UNESCO, FAO, IAEA and the World Bank, with other water-related NGOs, and is a member of the World Water Council and UNwater. IAH is also affiliated to the International Union of Geological Sciences.
