The Commission has increased the generation and exchange of knowledge regarding transboundary aquifers, creating channels of communication and cooperation.

ACTIVITIES

TBA-Commission own website

With support from the IAH-Executive (Kellie Nicholson and Ian Dave), the TBA Commission created and fully developed a new website, which is now smoothly running at https://tba.iah.org/. The previously website located in IGRAC was deleted.

 Course: "Regional groundwater governance with an emphasis on transboundary aquifers"

Three members of the TBA Commission were invited by CODIA, UNESCO and CeReGAS to deliver a course on Regional Groundwater Governance with an Emphasis on Transboundary Aquifers to Latin American countries, in Spanish ("Curso Regional Gobernanza de Aguas Subterráneas con énfasis en Acuíferos Transfronterizos").

Laura Movilla, Lucia Samaniego and Alfonso Rivera helped developed this high-level course online from September 3 to 20, 2024.
